Reduction of intake for B.Ed. course from five basic units to three basic units i.e. 150 Sub: intake i.r.o D.M.College of Teacher Education, Imphal, Manipur - 795001: Decision 198th ERC, Meeting (Code No. ERCAPAPE00169)

Sir/Madam,

The Eastern Regional Committee in its 198th meeting held on 20th – 21st November 2015 considered that the D.M.College of Teacher Education, Imphal, Manipur - 795001 (Code No.ERCAPE00169) is recognized for B.Ed course with an annual intake 230 since 12.11.2002. As per NCTE Regulation 2014 revised order was issued on 31.05.2015 for five basic units i.e. 250 intake in B.Ed course which require additional facilities like additional built up area, additional infrastructure and additional teaching faculty as NCTE Regulation 2014.

The Director, University and Higher Education, Government of Manipur vide letter No. 3/3-840/98/(Pt.111) dated 30th July 2015 has informed that the above conditions was thoroughly examined in respect of the above college and the State Government of Manipur has permitted intake to D.M. College of Teacher Education three basic units i.e 150 intake only.

In view of the above the committee decided as under:

- The decision of the Government of the Manipur is accepted. Accordingly, a letter be issued to the institution to reduce the intake in B.Ed course from five basic units to three basic units i.e. 150 intake only from the academic session 2016-2017.
- In view of the above decision of ERC, the request of Government of the Manipur for reducing the intake for B.Ed course from five basic units to three basic units i.e. 150 intake only from the academic session 2016-2017 is accepted and the institution is permitted to run B.Ed. course with an intake of three basic units i.e. 150 from the academic session 2016-2017.
