### **ORDER**

WHEREAS, DM College of Teacher Education, Imphal, Manipur- 795001 (Code No. MP-S/ E-2/96 & APE00169) was granted recognition for conducting B.Ed. course of one year duration with an intake of 180 from the academic session 1997-1998 vide ERC's order No. 2799(12) dated 11.02.1997. Permission was granted to the institution vide ERC's orders dated 13.10.2000, 11.05.2001, 05.09.2001 & 12.11.2002 with an intake of 240, 180, 273 & 230 respectively.

- 2. AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 250 (Five basic units) from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/APE00169/B.Ed.(Revised Order)/2015/32608 dated 31.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS,** the ERC in its 198<sup>th</sup> meeting held on 20<sup>th</sup> 21<sup>st</sup> November, 2015 considered the letter dated 30.07.2015 received from the Director, University and Higher Education, Government of Manipur and as decided, the intake has been reduced from 250 (Five basic units) to **150 (Three basic units)** from the academic session 2016-2017 vide ERC's order No. ERC/7-198.12.2/APE00169/B.Ed./2015/39508 dated 04.12.2015.
- 4. **AND WHEREAS,** on the basis of implementation of NCTE Regulations 2014, Revised Recognition Order was issued on 26.05.2015 from the academic session 2015-2016 subject to fulfillment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update institutional website and to comply the same to the ERC. The ERC in its 267<sup>th</sup> meeting held on 10<sup>th</sup> 11<sup>th</sup> February, 2019 considered the matter and decided, 1<sup>st</sup> Show Cause Notice was issued on 21.02.2019 to the institution.
- 5. **AND WHEREAS,** the institution has failed to submit reply of Show Cause Notice within the stipulated time period. The ERC in its  $271^{st}$  meeting held on  $24^{th} 25^{th}$  April, 2019 considered the matter and decided, Final Show Cause Notice was issued on 18.05.2019 to the institution.
- 6. **AND WHEREAS**, the institution has again failed to submit reply of Final Show Cause Notice within the stipulated time period. The ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 considered 1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019 and decided that Withdrawal order under section 17(1) of NCTE Act, 1993 be issued to the institution on the following grounds:-

(i) Approved faculty list by the concerned affiliating body along with requisite documents.

(ii) Approved building plan by the concerned competent Govt. Engineer/Authority.

(iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.

- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit. No reply received and the stipulated time period has already been over.
- 7. **AND WHEREAS,** The ERC in its 277<sup>th</sup> Meeting held on 19<sup>th</sup> 20<sup>th</sup> Dec, 2019 reviewed the matter and decided as under:-

Reply of the institution has already submitted to this office on 27.03.20 19.

Hence, the committee decided that the decision to withdraw of the recognition stand cancelled and institution reply received shall be placed in the forthcoming ERC meeting.

- 8. **AND WHEREAS,** the ERC in its 279<sup>th</sup> Meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and observed as under:-
  - (i) Appointed teaching staff is not sufficient to run 3 units (150) of B.Ed. course.

Hence, reduction of 01 unit (50 intake) from 150 intake from the next academic session i.e. 2020-21.

9. **AND WHEREAS,** a letter dated 13.01.2020 received in ERC, NCTE on 07.02.2020 from the Director of University and Higher Education, Govt. of Manipur. The ERC in its 280<sup>th</sup> Meeting held on 29<sup>th</sup> February 1<sup>st</sup> March, 2020 reviewed the matter and observed as under:-

The institution has appointed Part-time teacher, which is not permissible as per NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

- 10. NOW THEREFORE, recognition granted to the institution viz. DM College of Teacher Education, Imphal, Manipur- 795001 (Code No. MP-S/ E-2/96 & APE00169) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.
- 11. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of the issue of the order.
