### **ORDER**

WHEREAS, DM College of Teacher Education, Imphal, Manipur-795001 (B.Ed.) was granted recognition for B.Ed. Course with an intake of 230 vide ERC Order No. ERC/7-29/2002/4013 dated 12.11.2002 from the academic session 2003-2004, followed by revised recognition order No. 32608 dt. 31.05.2015 with an intake of 250 (five basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 198<sup>th</sup> meeting held on 20<sup>th</sup> 21<sup>st</sup> November, 2015 considered the letter dated 30.07.2015 received from the Director, University and Higher Education, Government of Manipur and as decided, the intake has been reduced from 250 (five basic units) to 150 (three basic units) from the academic session 2016-2017 vide ERC's order No. ERC/7-198.12.2/APE00169/B.Ed./2015/39508 dated 04.12.2015.
- 3. AND WHEREAS, the ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February 1<sup>st</sup> March, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-280.6/(MP-S/E-2/96 & APE00169)/B.Ed./2020/62519 dated 03.03.2020 from the academic session 2020-2021 to the institution.
- 4. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 03.03.2020. The Appellate Authority vide its Order No. 89-93/E-157972/2020 Appeal/14<sup>th</sup> Mtg.-2020/28<sup>th</sup> July, 2020/93156 dated 15.09.2020 decided that appellant institution is required to submit to ERC the approved list of faculty in original within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 5. **AND WHEREAS**, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020 and the committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 150 students (03 units) to be issued.

- 6. NOW THEREFORE, recognition withdrawn vide order dated 03.03.2020 to the institution viz. DM College of Teacher Education, Imphal, Manipur-795001 for B.Ed. course is hereby restored recognition with an annual intake of 150 students (03 units).
- 7. The terms and conditions of the order F. ERC/7-198.12.2/ERCAPE00169/B.Ed./2015/39508 dt. 04.12.2015 issued to the institution shall remain same.
