No. 7(2)/16/2008 - S/HE : Whereas the Manipur Public Service Commission, Imphal vide their letter No. 7/12/2006 - MPSC(DR) Dated 20th December, 2008 has recommended 145 Candidates for recruitment to the posts of Lecturers in different subjects in Government Colleges subject to the outcome of W.P.(C) No. 685 of 2007 and related cases arrayed in the Hon'ble Guahati High Court.

And whereas the Hon'ble Guahati High Court, Imphal Bench in the interim orders dated 05.01.2009 passed in W.P. (C) of 4 of 2009 [Ak. Ashakumar Singh Vs The MPSC and 4 Ors.], dated 07.01.2009 passed in W.P.(C) No. 14 of 2009 [Th. Bipin Singh Vs the State of Manipur & 2 ors.] and dated 12.01.2009 passed in W.P.(C) No. 10 of 2009 [Dr. Th. Meghajit Singh & Ors Vs The State of Manipur & Ors], has directed the State Government not to issue appointment orders in respect of the 3(three) candidates recommended for Computer Science, Km. Oinam Jayalakshmi Devi of Environmental Science and the following Candidates viz. Anand Yendrembam of Computer Science, Dhanamanjuri Lourembam of English and R.K. Reetu of History.

Now, therefore, the Governor of Manipur is pleased to appoint the candidates recommended by the Manipur Public Service Commission, Imphal vide their letter No. 7/12/2006- MPSC(DR) Dated 20.12.2008 shown in the Annexure, to the posts of Lecturer in the subjects noted above their names, in the Government Colleges, Manipur, on temporary basis, in the scale of pay of Rs. 8000- 275 - 13,500/- per month with usual allowances as admissible under rules from time to time, with effect from the dates the Lecturers join duties subject to -

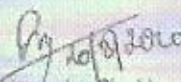
